

# Thurrock Muslim Parents Society Privacy Policy

We take your privacy very seriously at Thurrock Muslim Parents Society. We will only ever email you if you have specifically requested we do so - if you have subscribed to our mailing list or contacted us. We will never sell or share any user information with third parties. This Privacy Policy governs the way Thurrock Muslim Parents Society collects, uses, maintains and discloses information collected from users of [www.thurrockmuslimparents.com](http://www.thurrockmuslimparents.com). This privacy policy applies to the site and any products and services offered by Thurrock Muslim Parents Society.

## Personal Identification Information

We will collect personal identification information from users only if they voluntarily submit such information to us.

Such information may be given to us in a variety of ways, including, but not limited to, filling out a form, subscribing to our mailing list or sending us an email, and in connection with other activities, services, features or resources that we make available on our site.

Users may be asked for, as appropriate, name, email address and phone number. Users can always refuse to supply personal identification information, except that it may prevent them from getting a reply to an enquiry (as we cannot respond without contact information).

## Non-personal Identification Information

Thurrockmuslimparents.com collects **non-personal identification information** about users whenever they interact with our site. Non-personal identification information includes demographic information such as the country and city in which the user is located. Page views and duration of visit are also recorded.

## Cookies

Our site may use third party "cookies" to enhance user experience. Each user's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. Users may choose to set their web browser to refuse cookies, or to alert them when cookies are being sent. If they do so, note that some parts of the site may not function properly.

## How we use collected information

Thurrock Muslim Parents Society may collect and use user's personal information for the following purposes:

- **To improve the site.**  
We may use feedback to improve our products and services.
- **To send periodic emails.**  
We may use the email address to respond to enquiries, questions, and/or other requests. If a user decides to opt-in to our mailing list, they may receive occasional emails that may include news, updates, related product or service information, etc. If at any time the user would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email.

## Sharing your Personal Information

**We do not sell, trade, or rent any user personal identification information to others.**

### Third party websites

On the 'Local Businesses' page of our site, users will find advertising that links to the sites and services of local Muslim businesses. We only advertise the service or business as a local provider to help our Muslim community connect and benefit from local customers. However, we have not checked the quality, reliability, value etc and are not responsible for the practices employed by the businesses/services linked from our site. It is up to everyone to make their own contact and do their own further research when deciding whether to use the business/service. Similarly, any issues/disputes that may arise out of contact or use with these businesses are the sole responsibility of the individual to resolve directly with the business/service provider.
